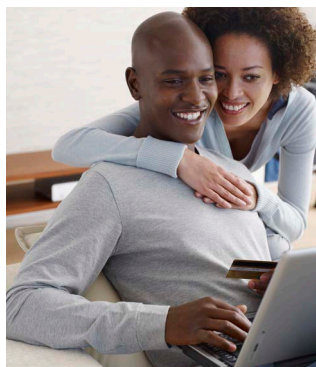

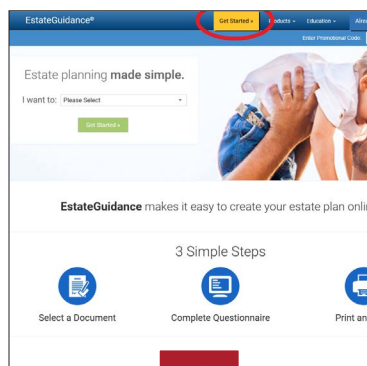
Online will preparation allows you to document your final wishes, such as

- Naming a guardian to care for minor children

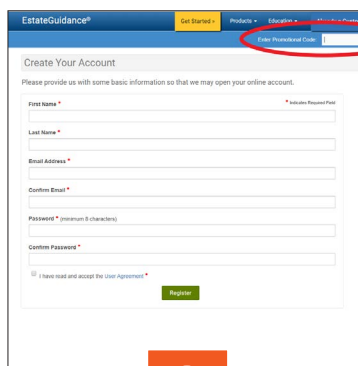
Online will preparation is straightforward.

- You can make unlimited revisions at no cost.

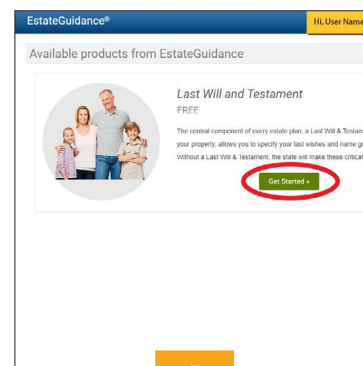
